FEE PROTECTION SCHEME & MEDICAL INSURANCE

Fee Protection Scheme

- CPE requires all students' (local and international students) paid course fees to be protected. As required by CPE, we have in place a Fee Protection Scheme (FPS). The FPS serves to protect the student's fees in the event the PEI is unable to continue operations due to insolvency, and/or regulatory closure. In addition, the FPS protects the student if the PEI fails to pay penalties or return fees to the student arising from judgments made against it by the Singapore courts. The FPS is available in 2 forms, either insurance or escrow scheme. This scheme is compulsory for all students. For the detail please refer to our website at www.shrm.edu.sg.

Medical Insurance

As required by CPE, SHRM has purchased a group medical insurance scheme for all its students. This medical insurance scheme has an annual coverage limit of S\$20,000 per student, covers up to B2 ward in government and restructured hospitals and provides for 24-hour coverage in Singapore and overseas (if the student is involved in SHRM-related activities) throughout the course duration.
